### **2026 Quilts of Enchantment Quilt Show**

Dear Vendor:

Las Colcheras Quilt Guild will be hosting our 17<sup>th</sup> Judged Quilt Show on Friday and Saturday, March 27-28, 2026, at the Las Cruces Convention Center.

We hope you will accept this invitation to join us as a participating vendor. Vendors will be located in the room with the quilts. Vendor space is limited, so they will be assigned on a first-paid basis. The deadline for first right of refusal for previous booth space and open booth spaces will be August 1, 2025 with a deposit of \$50. Each 8'x10' fully draped booth will be \$300 and contain one 8' table and two chairs with discounts for multiple booths and/or early payment in full. Electricity is offered at an additional cost of \$50 per drop. Back and side drapes are eight feet in height. Pinning to the actual drapes is not allowed.

A city vendor permit is not required in the Convention Center however, a New Mexico sales tax packet will be provided for each vendor. A snack bar will be available during the show. There is a loading area behind the convention center with ramps directly into the exhibit hall.

There will be a special area for vendor demonstrations, which will take place throughout the Quilt Show. We welcome your participation in providing a demonstration of your products or techniques. Guild members will be available to assist you if needed.

We are planning hourly door prizes and welcome your contribution.

Bed and breakfast at a guild member's home is available. This is a great way to make new friends or reconnect with old friends.
